**Invitation to the "reopening of the 35th INF-FNI WORLD CONGRESS 2016 at NH
hotels « Airport Conference Center » at Vienna Airport in Austria on 22.07.2017**

Dear INF-FNI Federations,

Following the decision of the Legal Council dated 20/12/2016 we invite you to the "reopening" of the 35th World Congress 2016 in order to proceed with the new INF-FNI presidential elections.

Following the Legal Council's decision and other directives:

- Venue of the conference: NH "Airport Conference Center" near Vienna airport on 22.07.2017 between 14 and 16 hours, room AUSTRIA 1.
- The conference will be chaired by a member of the Legal Council.
- The agenda and the road map from Vienna Airport are available in the attached registration form.
- Registration forms must be sent to the INF-FNI Secretariat **2 months** before the conference date. Registration of a substitute delegate is provided in the form. (Option)
- Candidates for the presidential elections must, by way of derogation from § 10, point 1 of the Rules for AG INF-FNI, be sent to the INF-FNI Secretariat **2 months** before the conference and must comply with the requirements of this Regulation. 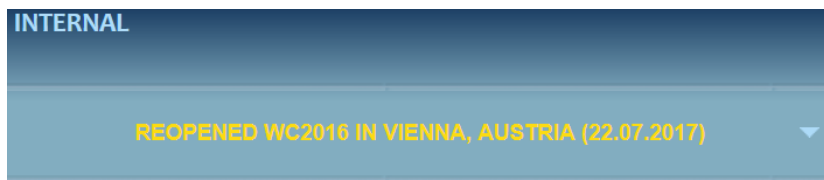
The CJ wishes to clarify:

- There will be no debates before the vote;
- The candidates are invited to submit a memorandum describing their projects for the duration of their mandate (2017-2020) so that all candidates can present themselves usefully before the vote.

(Deadline for submission of these documents: 21 May 2017 at 24 hours)

- The INF-FNI secretariat will send the received candidatures to the federations after the registration deadline. (1)
- Proxies must be sent to the INF-FNI secretariat 1 month before the conference. In order to prepare your prospective proxies, a list (1) of participating federations will be displayed in our protected download two months before the conference. It is necessary to observe the instructions for proxies given in § 9, points 9 & 10 of the INF-FNI Statutes available in our "open" download under "INF-FNI Documents" or by means of the following link:

- The voting power list of WC2016 applies. (1)
- Although this conference is a "reopening" of the WC2016 and that participation in travel costs was intended only for federations that did not attend CM 2016, the EC, upon LC's advice, decided in its meeting of 24 February 2017 to subsidize all federations in a manner identical to that of a normal congress.
