**(1)** Activity reports and discussion points will be concatenated in two separate PDF files upon receipt and are publicized immediately in the “protected” download.

**(2)** For Federations needing a translation of their documents, the INF-FNI can take it over. The costs for this purpose are 15€ per page (ARIEL 12 size) and will be charged on the current federations’ account. These documents must be sent at least 14 days before the deadline to INF-FNI and under DOC (x) format.

All documents must be sent in the 3 official INF languages to the INF-FNI Office through the official E-mail address of the respective federation. (Or by postal mail) to -> [naturism@inf-fni.org](mailto:naturism@inf-fni.org)

For all correspondence, the date of the postal stamp (or E-mail date) is considered.

Following the INF-FNI motion N° 5 (Ref: 7-1-8) related to a statutory amendment accepted during WC2016, all federations are required to send a list of the names of their executive board (President, secretary and treasurer) to the INF-FNI office 2 months after their GA with postal address, E-mail address and phone number with international call sign.

Outgoing (or appointed by CC) candidates are eligible for re-election. All applications (end of mandate, renewable or new) must to be submitted by the federations to INF-FNI office with a cover letter signed by 2 members of their committee on paper with federation's letterhead within the set deadlines.

Candidates who are absent during the vote must attach a letter of acceptance in case of their election to a position.
